FREQUENTLY ASKED QUESTIONS (FAQs)

Funding Specifics

- Q: How many funding rounds will there be?
- A: The Council anticipates 3 funding cycles.
- Q: How much funding is available in this round?
- A: Up to \$5.8 million each Fiscal Year (FY), beginning 2010-2011.
- Q: What are the minimum and maximum amounts that will be awarded per individual grants?
- A: There are no minimum award amounts. The maximum request for funding is limited to \$250,000. Larger grant awards may be considered for organizations that work together to develop joint planning documents that cover all jurisdictions involved.
- Q: When must the funds be expended?
- A: Currently, appropriation of the funds is pending so there is no specific timeline. In the past, the timeline for bond funds has been three years to encumber the funds (via the execution of a grant agreement) and an additional two years to fully expend.
- Q: Are matching funds required?
- A: No. Matching funds are not required for this program. However, the Council encourages leveraging all resources, including other sources of funds.
- Q: At the time of application, does the project need to be completely funded other than the funds requested through the grant process?
- A: No. However, other funds necessary to complete the plan should be identified and applied for <u>and</u> a contingency plan should be provided describing how the Applicant will proceed with the plan if these other funds are not awarded.

Eligible Applicants

- Q: What types of organizations are eligible for this grant?
- A: Eligible applicants are defined in statute as -
 - Council of Governments
 - Countywide Authority
 - Metropolitan Planning Organization
 - Local Government (city, county, city and county, district, or local joint powers authority)
 - Nonprofit Organization
- Q: Are Federal Agencies eligible to apply for a grant?
- A: No. Federal Agencies are not eligible applicants.
- Q. Is there a way for organizations that are not deemed "eligible" to participate in this grant opportunity?
- A: Entities not eligible for funding can partner with eligible entities as listed above. Collaboration, including partnerships, is highlighted in the guidelines as a priority.

Eligible Plans

- Q. Is updating an already existing urban green plan eligible?
- A: No. Statute specifies that grant funds are to be used "... for the purpose of **creating** urban greening plans that will serve as the master document guiding and coordinating greening projects in the applicant's jurisdiction." [Emphasis added]
- Q. Are Climate Action Plans eligible for grant funding?
- A: No (see answer to question, above).

Eligible Costs

- Q: Are costs directly related to the urban greening plan, but incurred prior to the project award date or after the end of the project performance period eligible for reimbursement?
- A: No. Costs must be incurred during the project performance period to be eligible. The Project Performance Period is the beginning and end dates of the grant agreement.
- Q: If awarded a grant, will the applicant be able to use an overhead rate for personnel and/or employee services?
- A: No. All eligible costs must be tracked and correlated directly to development of the plan by specific project codes, employee timesheets, invoices, etc.

Application Process

- Q: When are the grant applications due and awards announced?
- A: Applications are due April 30, 2010 by 5:00 p.m. Awards are anticipated to be announced in September/October and are contingent upon inclusion in and enactment of the State budget, and available cash.
- Q: Is there a limit on the number of applications each applicant can submit?
- A: No. There is no limit on the number of submittals per applicant.
- Q. My organization has several eligible plans that we feel are competitive. Should we submit one application for all plans, or individual applications for each?
- A. Submit one application for each individual plan. Each plan (as defined on page 2 of the guidelines) will be evaluated and scored by the committee on an individual basis.
- Q. Will an applicant be penalized for submitting more than one application?
- A. No. The committee will evaluate and score each plan on its own merit.
- Q. Can an applicant apply for a grant to create an urban greening plan and also apply for a separate grant to implement an urban greening project?
- A. Yes. The Council encourages applicants to submit proposals for either or both programs, as long as the proposals meet the stated requirements.

Each application will be scored independently and must have no interdependence on the other application, either stated or implied. Each application should also note the future of the proposed action (plan or project) if either application is <u>not</u> funded. For an Urban Greening project, the budget should detail that no more than 25% of the total grant will be spent on non-construction costs such as project design, administration, or CEQA compliance.
